Shipper Carton Ref. Code: N101-56	 For bulk packed wipes each outer carton is poly lined 20 inners or 2000 bulk packed sachets per shipper carton. The shipper cartons are completely sealed with clear adhesive tape. A Gammatex[™] sticker will be fixed to the top corner of the shipper carton. The sticker is a visual indicator which changes from yellow to red upon exposure to Gamma irradiation. Sterility and dose levels are only confirmed by the Certificate of Irradiation, issued to Naturelle by the sterilization supplier. The approved shipper carton. 	



Pallet: Standard	 Each pallet must have a cardboard lining on the base. Shipper cartons are placed so that labels are visible. The completed pallets will contain 50 outer cartons built with 10 boxes per layer and 5 layers high. All four corners must be protected with pallet corners. Each pallet must be completely shrink wrapped to avoid damage in transit and sealed with security tape. The packing slip generated for the product will be affixed to the pallet.
